



Important information – Additional Terms of Business for sponsors

All sponsors/supporting companies will be provided with an individual company sponsor registration account (CSRA) to register their booth staff and employees for LINC 2025.

1. Registration fees:

Sponsor course registration [early bird]	950 EUR	Registrations until 31 Oct. 2024
Sponsor course registration [reduced fee]	1.150 EUR	Registrations from 1 Nov. until 06 Dec. 2024
Sponsor course registration [regular fee]	1.350 EUR	Registrations until 20 Jan. 2025
Sponsor course registration [on-site fee]	1.350 EUR	Registrations from 21 Jan. 2025

The registration fees include:

- Full access to all sessions and the industry exhibition
- Daily packed lunch
- Coach shuttle service as provided to and from the Messe Leipzig
- Access to the on-demand content for 6 months after the course.

Please note that Provascular does NOT delineate between regular course registrations and sponsor registrations, as all tickets provide access for all participants to all sessions and areas.

If you want to register physicians via your account, please let us know, that we can add these registration fees to your account as well.

2. Registration deadlines/payment deadline/cancellation terms/handling fees:

After the registration deadlines have been passed (see table above), the invoices are sent out and are due for online payment immediately. After the regular registration fee has passed, payments for additional registrations are due at the time of registration. ALL registrations must be paid in full for the tickets to be valid on-site. No acceptations will be made.

Payment Methods: credit card (Visa, Mastercard, American Express, Discover, Diners Club, and China UnionPay), Apple Pay, Google Pay, Paypal, Link, Bancontact, EPS, giro pay or iDeal.

No cancellations will be accepted and refunded at all times.

Any change requested (re-bookings, name/e-mail address change) will result in an 80 Euro handling fee!

3. Registration rules/complimentary badges:

Purchased registrations need to be assigned to the participants before Monday, 20 January 2025.

To assign the registrations to the participants attending LINC on-site, first name, last name and individual e-mail address are required. Please note, that each e-mail address can be used only once.

Once assigned, we offer the opportunity to transfer a course registration to another participant for a **handling fee of 80 EUR**. To do so, please contact Provascular by e-mail at registration@leipzig-interventional-course.com

Please purchase all registrations within your company account, complimentary as well as additional registrations. It does not matter who of your staff members receives the complimentary registration as all tickets have the same rights.



All placeholders (like “Barista 1”, “Staff 2” etc.) are not accepted, and will be charged with a handling fee of 80 EUR, to assign them to a participant.

The number of complimentary registrations is stated in your sponsorship agreement and will be added to your company sponsor registration account.

4. Invoice address/Invoicing:

You need to enter your correct invoice address, VAT-ID number (for companies registered in the EU), purchase order number (if required by your company rules/available), **before** you request the payment or before we send the invoice according to the deadlines above.

Registrations entered in this account will all be charged to **ONE invoice address only**.

Any change in the invoice address after the invoice has been issued will be charged with a **200 EUR handling fee**.

The invoices will be sent by e-mail to the company main contact shortly after the deadline has passed. Invoices are generated by Provascular GmbH.

5. Additional on-site information:

Only registered attendees are allowed to enter the congress area, including meeting rooms, exhibition hall, and lecture halls/arenas.

Badges are personal entry passes and may **NOT** be transferred to another person. Picture IDs may be checked. Any violation of these rules will have legal consequences.

Please keep an eye on your badge. **Badges will not be re-printed in case of loss. No exceptions will be made.**

No-shows will not be refunded.

A registration is always transferable to another person at any time for a handling fee of 80 Euros.
