## GENERAL TERMS OF BUSINESS

#### 1. Registration/payment

- 1.1. Participants can enrol online under: [www.leipzig-interventional-course.com](http://www.leipzig-interventional-course.com). You will receive a confirmation and invoice via e.mail. The amount of the registration fee depends on the date of registration, not on the date of payment. <sup>1)</sup>
- 1.2. LINC 2022 offers registration for on-site and for virtual participation. Both registration types include access to the virtual platform, as well as for the on-demand content for 6 months after the course. <sup>1)</sup>
- 1.3. Payments
  - 1.3.1. Payments for virtual registrations are to be paid directly at registration.
  - 1.3.2. Payments for on-site registrations:  
Until 16 December 2021:  
On-site registrations are payable no later than 4 weeks after registration. If you fail this deadline, your on-site registration will be cancelled and your registration be changed to virtual participation.  
After 16 December 2021:  
On-site registrations are to be paid directly at registration. If payment is not made by 24 hours after registration your on-site registration will be cancelled and your registration be changed to virtual participation.
- 1.4. Any change requested after the original invoice has been issued will result in a 60,00 Euro (incl. 19% VAT) service fee.
- 1.5. Invoices are generated by Provascular GmbH. CongO GmbH is acting as an official representative on behalf of Provascular GmbH.
- 1.6. When you enrol for the congress, you accept our participation conditions, the congress fees and our exclusion of liability.
- 1.7. For the on-site event, you will not be allowed to access without a badge. Please keep your badge safely. It exists NO right for replacement in case of loss. You may be required to present your ID/Business Card for verification purpose.
- 1.8. For the on-site event you need to provide:  
proof of complete and current vaccination  
or  
proof that you have recovered from COVID 19 and have a positive antibody test  
or  
a negative test result, no older than 24 hours

We will provide the possibility for testing at the event.

Medical mouth-nose protection/FFP2 masks must be worn in the indoor area of the exhibition grounds. Please remember that persons suspected of being infected with COVID 19 are unfortunately not allowed to enter. We recommend the use of the federal government's Corona warning app.

#### 2. Cancellation

- 2.1. Participants may cancel registration at any time. <sup>1)</sup>  
Cancellation deadlines:  
Until 28 September 2021 a refund of 100% will be made, with a cancellation fee of 60,00 Euro (incl. 19% VAT).  
Until 16 December 2021 a refund of 50% will be made.  
After 16 December 2021 no refund will be made. Fees already paid will not be refunded. Invoiced amounts must be paid.
- 2.2. Instead of cancelling your registration, you can also nominate a replacement and we will change the reservation accordingly at a fee of 60,00 Euro (incl. 19% VAT) per name change. The new participant (replacement) will be required to pay the congress and service fees if they have not already been paid by the original participant. Fees already paid will not be refunded to the original participant. A change of registration will only become effective once the new congress participant has accepted our general terms of business. <sup>1)</sup>
- 2.3. Cancellation or change of registration must be made in writing in order to be valid. Cancellations or changes of registration by phone will not be valid. If you send a fax (+ 49 89 94 39 92 273) or an e-mail ([registration@leipzig-interventional-course.com](mailto:registration@leipzig-interventional-course.com)) this will be deemed sufficient in terms of compliance with the requirement to submit cancellations or changes of registration in writing.
- 2.4. Cancellation of on-site participation due to high-risk COVID 19 area declaration of your home country by the German RKI:  
Registration type will be changed to virtual participation. Price difference will be reimbursed until 16 December 2021.  
No reimbursement thereafter.
- 2.5. Cancellation of on-site event due to COVID 19:  
all on-site participation registrations will be changed to virtual participation. Price difference will be reimbursed.

If you have registered for on-site participation, but fail to confirm within the given time frame, your registration will be changed to virtual participation.

1) These terms do **NOT** apply for company registration accounts. The corresponding details are listed under **important information** in the respective company account.

#### 4. Hotel reservations

4.1. We have reserved a limited contingent of rooms in advance for the congress participants at the hotels listed in the registration form. Reasonable room rates will be offered. However, you may reserve rooms at more favourable conditions when booking accommodation through other reservation systems (e.g. on the Internet), since these systems usually book larger contingents in the respective hotels. In the low season you may find special short-term offers at prices below those we have negotiated. CongO GmbH will not assume any liability if higher room rates are charged to congress participants.

4.2. Room reservations may be cancelled according to the general business terms and conditions of Leipzig Tourist Marketing.

4.3. Due to the limited number of rooms, CongO does not guarantee that all congress participants will be able to reserve the room of their choice in the hotel selected, or that they will be able to reserve a room at all, for example if the contingent is exhausted. If circumstances require, reservation requests will be considered on a firstcome, first-served basis.

#### 5. Liability

5.1. CongO will be liable only for services actually performed by themselves in accordance with the statutory regulations. Any further liability is excluded. This shall apply in particular to third-party services provided by hotel and catering services, transfer and tourist services as well as other work performances or services. CongO will only act as an intermediary here. Liability claims for such third-party services may only be asserted against the respective service provider. In addition, CongO will be liable for faulty contractual performance, unlawful acts or, in the case of culpa in eligendo, for intent and gross negligence only.

#### 6. Programme

5.1. CongO expressly reserves the right to change the congress topics listed in the programme or to engage other lecturers. CongO also reserves the right to make changes regarding the announced Global Expert Exchange, without assuming any liability for any such changes.

#### 6. Privacy
