

LINC 2023 · GENERAL TERMS OF BUSINESS

1. Registration/payment

- 1.1. Participants can register online at: www.leipzig-interventional-course.com. You will receive a confirmation and invoice via e-mail. The registration fee is based upon the date of registration (CET), not on the date of payment. ¹
- 1.2. LINC 2023 offers registration for on-site participation. This includes on-demand content available for up to 6 months after the event (not included in day passes). ¹
- 1.3. Payments
 - 1.3.1. Payments for registrations:
Until 06 April 2023: Payments are due at the time of registration, but no later than 4 weeks after receipt of the invoice, if not paid at the time of registration. If you fail to meet this deadline, your registration will be cancelled.
After 06 April 2023: Registrations have to be paid directly at time of registration. If payment is not made within 24 hours after registration, your registration will be cancelled.
- 1.4. Any change requested after the original invoice has been issued will result in a 60 Euro service fee. ¹
- 1.5. Invoices are generated by the official representative of LINC, - Provascular GmbH.
- 1.6. When you register for LINC, you accept LINC's participation conditions, the congress fees and LINC's exclusion of liability.
- 1.7. You may be required to show your ID/Passport for verification purpose to pick up your badge. You will not be allowed to access the congress without a badge. Please keep your badge safe, as replacements won't be made without exception.
- 1.8. Payment methods: For online registration you can use a credit card (Visa, Master Card) or PayPal payments. On-site you can use Credit Card (Visa Card, Master Card), Debit Card or Cash payment only. Amex will not be accepted at any time.
- 1.9. All fees include the local applicable VAT.

2. Cancellation

- 2.1. Cancellation or change of registrations must be sent by e-mail to registration@leipzig-interventional-course.com
- 2.2. Cancellation deadlines: ¹
 - 2.2.1. Until 28 February 2023, a refund of 100% of the registration fee will be made, minus a cancellation fee of 100 Euros.
 - 2.2.2. From 1 March until 6 April 2023, a refund of 50% of the registration fee will be made, minus a cancellation fee of 100 Euros.
 - 2.2.3. After 6 April 2023, no refunds will be made. Fees already paid will not be refunded. Open invoice amounts must still be paid.
- 2.3. A registration is transferable to another person at any time for a processing fee of 60 Euros. If a reduced participation fee was booked by the original participant, proof of such must be provided so that it may apply to the new participant. The new participant (replacement) has to pay the congress and service fees if they have not been paid already. Fees already paid will not be refunded to the original participant. ¹

¹ These terms do **NOT** apply for company registration accounts. The corresponding details are listed under **important information** in the respective company account.

3. Liability

- 3.1. Provascular will be liable only for services actually performed by Provascular in accordance with the statutory regulations. Any further liability is excluded. This shall apply in particular to third-party services provided by hotel and catering services, transfer, and tourist services as well as other work performances or services. Provascular will only act as an intermediary here. Liability claims for such third-party services may only be asserted against the respective service provider. In addition, Provascular will be liable for faulty contractual performance, unlawful acts or, in the case of culpa in eligendo, for intent and gross negligence only.

- 4.1. Provascular expressly reserves the right to change the congress topics listed in the program or to engage other lecturers. Provascular also reserves the right to make changes regarding the announced Global Expert Exchange, without assuming any liability for any such changes.
